

SUMMARY ANNUAL REPORT

FOR BATTELLE MEMORIAL INSTITUTE DENTAL PLAN FOR BMI ACTIVE STAFF

This is a summary of the annual report of the Battelle Memorial Institute Dental Plan for BMI Active Staff, EIN 31-4379427, Plan No. 543, for period October 1, 2010 through September 30, 2011. The annual report has been filed with the Employee Benefits Security Administration, U.S. Department of Labor, as required under the Employee Retirement Income Security Act of 1974 (ERISA).

Basic Financial Statement

The value of plan assets, after subtracting liabilities of the plan, was \$1,011,838 as of September 30, 2011, compared to \$604,990 as of October 1, 2010. During the plan year the plan experienced an increase in its net assets of \$406,848. This increase includes unrealized appreciation and depreciation in the value of plan assets; that is, the difference between the value of the plan's assets at the end of the year and the value of the assets at the beginning of the year or the cost of assets acquired during the year. During the plan year, the plan had total income of \$8,418,168, including employer contributions of \$5,517,021, employee contributions of \$2,900,738, earnings from investments of \$153 and other income of \$256.

Plan expenses were \$8,011,320. These expenses included \$518,464 in administrative expenses and \$7,492,856 in benefits paid to participants and beneficiaries.
